



TERMS & CONDITIONS

TUITION POLICY FOR ALL CAMPS:

Our Winter and Spring Camps both have daily and weekly enrollment options available for parents. Full payments for these camps are due upon enrollment.

The tuition for our Summer Camp is composed of 2-week sessions. As a convenience to families to avoid making a one-time payment upfront, the contracted Summer Camp tuition is broken down into equal monthly installments from the moment Registration takes place to May 31st of the current year. However, the full tuition is still due as per the contract.

Parent further understands that the overhead expenses of its Camps do not diminish with the departure of some campers and that it is impossible for the camps to determine at the time of parents execution of their contract the damage and loss to the business that would occur due to the later cancelation/withdrawal of some of the campers who have enrolled. In addition, parent understands that Camp Lingua staffs, plans, markets, contracts, purchases, boards animals accordingly to its camp enrollment. Therefore, once the Registration has been submitted along with the Registration Fee and first month installment, or full payment of the Camp, the parent becomes liable for the entire tuition and fees and liquidated damages (and not a penalty) even if the camper is withdrawn, absent, or is involuntarily separated from the camp in strict accordance with our Terms and Conditions, "Refunds & Exchanges Policy for all Camps".

Changes made to camper enrollment Registration post enrollment date will be administered a \$50 administrative fee.

REFUND & EXCHANGES FOR ALL CAMPS:

The Registration fee is non-refundable and all camp tuition, meals, merchandise and services are non-refundable, exchangeable or transferable for any reason whatsoever including, but not limited to, misbehavior, illness, accidents, emergencies, natural disasters, pandemic, extreme weather, death, acts of God, etc. as we staff and plan for our camps according to enrollment.

If a camper misses one day or week of camp, there will not be compensation with other days or weeks of camp. If a participant never attends (no-show) or cancels the contract prior to the start date, on start date, middle of the camp or end of the camp there will NOT be refunds or exchanges.

Camp Lingua reserves the right to cancel any camp due to insufficient enrollment; refunds for all services, except registration fee will be refunded at that time. Camps that are cancelled by Camp Lingua will receive a refund of the remainder of the camp not received. All refunds due will be paid within thirty (30) calendar days.

LIABILITY FOR ALL CAMPS:

Camp Lingua LLC and its representatives will not be liable for loss, damage or injury to persons or property, except when such liability is imposed by law. Neither shall Camp Lingua LLC. be liable for services not supplied due to a reason out of its control.

TUITION POLICY FOR CLUB CAMP AFTER-SCHOOL PROGRAM & ALL EXTRACURRICULAR ACTIVITIES:

Our Club Camp After-School Program and all of our Extracurricular Activities including, but not limited to, horseback riding lessons, language training and school-subject tutoring are composed of a 10-month contract, from August 2019 to May 2020. The tuition for Club Camp and all other Extracurricular Activities are annually for the entire School Year or period covered by the contract. As a convenience to families to avoid making a one-time full payment upfront, the contracted annual tuition is broken down into 10 equal monthly installments. However, the full year tuition is still due as per the contract.

Parent further understands that the overhead expenses of the program do not diminish with the departure of some students during the course of the school year and that it is impossible for the Program to determine at the time of parents execution of their contract the damage and loss to the business that would occur due to the later cancelation/withdrawal of some of the students who have enrolled. In addition, parent understands that Camp Lingua staffs, plans, markets, contracts, purchases, boards animals accordingly to its school year enrollment. Therefore, once the Registration has been submitted along with the Registration Fee and first months tuition, or full payment of the program for the entire school year, the parent becomes liable for the entire year's tuition and fees and liquidated damages (and not a penalty) even if the student is withdrawn, absent, or is involuntarily separated from the Program UNLESS the parent terminates the Contract in strict accordance with the termination procedures set forth in our Terms and Conditions paragraph, "Refunds & Exchanges Policy for Club Camp After-School Program and all Extracurricular Activities.

Changes made to student enrollment Registration post enrollment date will be administered a \$50 administrative fee.

REFUNDS & EXCHANGES POLICY FOR CLUB CAMP AFTER-SCHOOL & ALL EXTRACURRICULAR ACTIVITIES

The Registration fee is non-refundable and all ongoing monthly Club Camp tuition and extracurricular activities including, but not limited to, horseback riding lessons, language training and school-subject tutoring are non-refundable, exchangeable or transferable for any reason whatsoever including, but not limited to, misbehavior, illness, accidents, emergencies, natural disasters, pandemic, extreme weather, death, acts of God, etc as we staff and plan for our program according to enrollment.

Tuition for Camp Lingua's Club Camp After-Care Program and all of its Extracurricular Activities may be cancelled for future months at any time throughout the school year. A written request must be emailed two weeks (14 days) prior to the next scheduled payment date for the preceding month in order to guarantee a cancelation of future payments and enrollment for this program. A penalty fee in the amount of any/all discounts awarded to customer upon enrollment will be charged at the time of cancelation.

Camp Lingua reserves the right to cancel any program due to insufficient enrollment; refunds for all services, except registration fee will be refunded at that time. Programs that are cancelled by Camp Lingua will receive a refund of the remainder of the Program not received. All refunds due will be paid within thirty (30) calendar days.
